



# Climatic change Policy

Climatic change is one of the most important challenges humanity is facing in the 21<sup>st</sup> century. The use of fossil fuels has led to a significant increase in greenhouse gas emissions that have accelerated global warming. ROVI pharmaceutical group, which consists of Laboratorios Farmacéuticos ROVI S.A. (Madrid and Granada), ROVI Pharma Industrial Services S.A.U. (Madrid, San Sebastián de los Reyes and Alcalá de Henares), Pan Química Farmacéutica S.A. (Madrid), Laboratorios Farmacéuticos ROVI, S.A. (Portugal), ROVI GmbH (Germany), ROVI Biotech Limited (United Kingdom), ROVI Biotech, S.R.L. (Italy) and S.A.S.U. ROVI (France), recognize the seriousness of the threat posed by this global warming, which must necessarily be addressed jointly and in a coordinated manner by governments, multilateral organizations, the private sector and society as a whole.

In this sense, ROVI is committed to assuming a leadership position in the fight against climatic change, to promoting a social culture aimed at raising the awareness of all its stakeholders about the magnitude of this challenge and the benefits associated with addressing its solution, identifying specific actions in the field of mitigation and adaptation.

The Society's leadership commitment is consistent with the United Nations approved Sustainable Development Goals (SDAs) and an ambitious and efficient approach to their implementation. With this, ROVI wants to actively and resolutely contribute to a sustainable future, minimizing the environmental impact of all its activities and promoting the adoption of all actions within ROVI's reach to this end, an effort that must be compatible with social and economic development through the sustainable generation of employment and wealth.

This Policy against Climatic Change is formalized in order to articulate and disseminate the ROVI Group's commitment against climatic change.

## Basic principles of action

To achieve the implementation of its commitment, ROVI will be guided by the following basic principles of action

### **Reduction of greenhouse gas emissions**

Greenhouse gas emissions come both from production activities and from the climatization of the facilities and vehicles in ROVI's sales network. This is why we are committed to reducing CO<sub>2</sub> emissions every year.

### **Reduction of non-greenhouse gas emissions**

Clean air is essential for our health and for the environment. But since the industrial revolution, the quality of the air we breathe has deteriorated considerably, mainly as a result of human activities. That is why since ROVI 2005 it has been striving to improve air quality by identifying the gases emitted by its activities, both greenhouse and non-greenhouse, controlling these emissions of harmful substances into the atmosphere and establishing measures to reduce these emissions or eliminate them.

### **Carbon neutrality**

Carbon neutrality is achieved when the same amount of carbon dioxide (CO<sub>2</sub>) that is emitted into the atmosphere, is removed from it by different routes reaching a zero balance, also called a zero-carbon footprint. The basis of this neutrality in ROVI will be the measures to reduce emissions and offset those that cannot be avoided through the Emission Reduction Certificates of socially and environmentally responsible projects
