- Training and coaching all personnel so that they have the knowledge in preventive matters for the development of the activity in their workplace.
- Considering the *consultation and participation* of the company's personnel and their representatives as a fundamental part of our preventive culture.
- Promoting a healthy work environment and valuing the collaboration of our employees, contractors, temporary employment agencies and stakeholders in health and safety management and continuous improvement.
- Integrating gender and generational diversity perspectives, as well as any other personal characteristics in preventive management.
